We, the partners of the ESSENCE project call for action among all relevant stakeholders including policy makers, higher education institutions and all other providers of higher and lifelong learning education in the European Union.

- Following the results and the potential achieved during the project implementation in terms of identifying relevant intervention areas and developing trainings in the field of soft skills through collaboration between higher education providers, business sector and non-governmental organisations.
- Aware of the forecasts of desired competences in disruptive environments of digital and green transition.
- Aware of the present and forecasted skills gaps in European Union and across the world as contained in 2020 World Economic Forum Future of Jobs Report.

- Motivating students to develop life-long learning strategies, stress management and digitalization skills along with traditional skills,
